There will be no tents, tables, or chairs provided, please plan accordingly. Deadline for Applications is Friday, April 15, 2011. The Festival hours of operation are Saturday, 10a.m. – 6p.m. and Sunday 11a.m. – 5p.m. Any vendors shutting down before the Festival is over will not be asked back again. We ask that you respect others and help make this a profitable event for everyone concerned. Please be considerate when unloading and loading and limit your time on the curb to 30 minutes. This is a very busy area and on the highway, we would like to give everyone equal opportunity to unload and load their things. Booth spaces are assigned on a first come first serve basis the earlier your application is turned in the closer you will be. There will not be any booths assigned prior to Friday, April 29th at 5p.m.

Vendors must report and pay their own sales tax.

NO GUNS OF ANY KIND, NO FIREWORKS OR POPPERS WILL BE ALLOWED OR SOLD IN BOOTHS. NO FAKE CIGGERATES OR CIGARS WILL BE ALLOWED. PLEASE USE YOUR BEST JUDGMENT ON ITEMS TO EXHIBIT.
