We only accept check, cash, or money order. NO CREDIT CARDS. Tables are not guaranteed until payment is received and absolutely no reservations will be accepted without payment.

Dealers are required to collect and report sales tax to the Texas Comptrollers Office.

The Show is Saturday, April 30th 9:00 AM-6:00 PM and Sunday, May 1st 10:00 AM to 4:00 PM. Vendors are required to be open for business for the duration of the show hours both days. There will be around the clock security.

Vendors will be allowed to set up Friday April 29 from 5:00 PM to 8:00 PM and on Saturday, April 30 from 7:00 AM to 9:00 AM. All setup must be complete by 9:00 AM.

Gun & Knife Show Rules

1. All local, state and federal laws must be followed. All vendors must follow the local, state and federal laws as they apply to sales, trades and other transactions. Vendors are responsible for collecting and reporting Texas Sales Tax.
2. Please NO concealed handguns. You will be subjected to search at anytime, this also pertains to vendors.
3. You will not be allowed to carry loose cartridges, loaded weapons or magazines at anytime.
4. There will be no loaded firearms carried in holsters, pockets, belts, purses, bags, etc. (only uniformed law enforcement officers).
5. All firearms must have tie-backs or other locking devices installed to render them inoperable. Ties are available for purchase at the show.
6. No illegal firearms or other items prohibited by law will be permitted.
7. No switch blade knives, brass knuckles, throwing stars, butterfly knives, or nunchuks are allowed to be displayed or sold.
8. No food or drink items will be allowed to be sold; there will be a concession stand available.
9. All vendors are responsible for their own table security.
10. No refunds will be given for no-shows.
11. Promoter assumes no liability for loss of personal property, injuries or business interruption.
12. There will be no conduct, activity, merchandise, or materials allowed that are not in the best interest of the show. This is at the sole discretion of the Ballinger Chamber of Commerce.
